The Customer hereby (i) acknowledges that it has received and has read the Quote and (ii) agrees to be bound by the terms and conditions of the Quote, including without limitation the terms and conditions in the Quote relating to disclaimers of warranties and limitations of liability.

## STANDARDS & WARRANTY

---

PLAE offers warranty on product and install (installation warranty is only valid on projects that PLAE is contracted to perform). For full product warranty details please use the following link: <https://plae.us/documentation>. PLAE will provide all documentation relating warranty, maintenance, and specifications of your chosen solution in an Operations and Maintenance Manual (O&M) at part of the project sign off and handover.

## EXCLUSIONS & DISCLAIMERS

---

- Production timeline does not start from the date of received signed PLAE estimate or purchase order. Product will not go into production without the deposit and a signed shop drawing.
- Product Only Scope - Please note product only Customers are responsible for receiving, offloading, and transporting material to the designated installation area. A forklift is recommended for all orders, while carpet pole is needed for turf only.
- For PLAE standard products, if an order is cancelled or modified (color, thickness, quantity, etc.) after the deposit payment has already been made, and prior to shipping, there will be a re-stocking fee of 35% of the material value from the original order. Custom equipment or flooring isn't available for restocking.
- Weekly Storage Fees of \$400 or 1.5% of product value (whichever is greater), will be incurred if notice to delay shipment is not received a minimum of 10 business days prior to scheduled shipment date. In addition to the first week of storage fee, an additional shipment fee for the relocation of material from PLAE's manufacturing plant to distribution center will be levied. PLEASE NOTE: Additional shipment cost is a one-time fee. All fees, including additional shipment costs, must be paid in full before any material ships to job site.
- If the project requires delivery to occur outside of normal business hours or multiple deliveries, without prior notice, PLAE will add a 30% freight surcharge.
- If additional tariffs or similar taxes or charges (collectively, "Taxes") that are imposed on PLAE in such a manner that increases the cost to PLAE of performing its obligation under this Quote or reduces the amount of any sums received or receivable by PLAE under this Quote, then PLAE will be entitled to increase the prices set forth in this Quote by an amount that compensates PLAE for such additional Taxes incurred or reductions suffered. Customer agrees to pay these escalated prices consistent with the terms set forth herein.
- No allowance has been made for major floor preparation. PLAE requires the sub-floor to meet ATSM F710 in which flatness does not exceed 3/16" over 10'. If the floor does not meet the forementioned standards, floor preparation will be required and quoted after the subfloor is viewed by PLAE's Project Manager.
- No allowance has been made for floor protection. If floor protection is required, PLAE will purchase and install floor protection after an approved change order has been issued.
- Demolition works outside of anything scoped is excluded.
- Other grinding or preparation works outside of the agreed scope is excluded.
- Moving of non-PLAE material and/or equipment. If movement of non-PLAE equipment is required, PLAE will review and provide a change order.
- Unless stated otherwise, PLAE has made no allowance for dust mitigations. If dust mitigations are required PLAE will purchase and install with an approved change order.
- Unless stated otherwise, PLAE has allowed for install on a concrete subfloor. If any form of other subfloor is present a change order may need to be issued. Alternatively, PLAE can provide a subfloor agreement, outlining the risk will be taken on by you the customer.
- If the job site is not ready at the agreed date and PLAE is not provided 72 hours notice for a date change, PLAE will invoice stand down rates at the rate of \$1615 per day.
- Any change to the works listed in this Quote will be treated as a variation of works and require applicable changes to be quoted, presented and signed of. This may include re-issuing documentation and combined with a PLAE change order.
- Unless stated otherwise, PLAE has made no allowance for payment or performance bonds. If bonds are required, a change order may need to be issued.
- Unless stated otherwise, PLAE has made no allowance for union labor. If union labor is required, a change order may need to be issued.
- Unless stated otherwise, PLAE has made no allowance for prevailing wages. If prevailing wages are required, a change order may need to be issued.
- All past due balances are subject to a Monthly Late Fee of \*1.5% or \$80, whichever is greater. (\* State maximums will apply)
